學費減免條例

一 減免內容

本條例減免學費，雜費仍需依照規定繳交。

二 申請資格：

1. 低收入 (附上年收入報稅單，若有領政府食物券亦可附上)
2. 過去一學年上課出席率在 90 % 以上
3. 學業成績優良 (附上成績單)

三 年限及名額限制

1. 本項減免辦法每年以不超過十名為限，如有特殊事故需增名額，則需經理事會同意。
2. 每家每年最多以兩名子女得減免為限。若當年申請者未滿十名，則不受此限。
3. 每名學生可連續申請減免兩年。若當年申請者未滿十名，則不受此限。

四 申請審核辦法：

1. 申請者需於每年 6 月底前提交學費減免申請表格，審核小組於秋季班開學前個別通知每位申請者審核結果。
2. 審核小組由校長，教師聯誼會會長和理事長組成來決定申請者資格。
3. 申請者需每年提出申請，由審核小組重新審核。
4. 接受減免者，家長服務規則與一般非減免者相同。

Guidelines For Tuition Exemption

Amended on 6/14/2003

Enacted by the board on 04/20/2002

I. Exemption detail:

This exemption applies to tuition only. Other applicable fees are to be paid by student as required.

II. Qualification:

1. Applicant must be from a low-income family and will be required to submit previous year income tax returns, and federal food coupon programs documentation if available.
2. Applicant must be enrolled at Torrance Chinese School currently and have maintained an attendance record of 90% or better during the previous school year.
3. Applicant's Chinese school academic achievement and citizenship must be of 80 or higher.

III. Limitations of number and duration of tuition exemption:

1. Maximum student eligibility: Up to 10 applicants will be granted tuition exemption annually. Any more than 10 students must be approved by Torrance Chinese School Board.

2. No more than two children per family per year may be granted tuition exemption. The Board may waive this limitation if the number of applicants is fewer than 10 for the year.

3. Each student may be granted tuition exemption for no more than two consecutive years. This limitation may be waived by the Board if the number of applicants is fewer than 10 for the year.

IV. Application and Review procedure

1. Timeline: Application must be received in June. Each applicant will be notified grant eligibility individually in early September.

2. Review Committee: Principal, President of Teacher Association and Chairman will form a committee to review all applications and grant tuition exemption only for that year.

3. Applicants are required to submit applications for reviewing exemption eligibility every year.

4. Parents of children who receive tuition exemption should not be exempted from general parent services.
